A succession lawyer and president of *Adoptee Rights Australia, Inc.*Catherine researches Australia's history of maternal-neonatal separation and its current expressions in child protection, adoption and surrogacy. She is a founding member of *Abolish Surrogacy Australia* (ABSA), a member of *Tangled Webs, Coalition for Accurate Birth Records* and the *NSW Committee on Adoption and Permanent Care* and fights for the voices of people traumatised by being separated from their mothers at or near to birth to be heard.

Bronwyn Williams Committee Member (21/6/19 -)

A retired lawyer and social worker and member of Women Speak Tasmania which is a network of activists focused on preserving women's spaces, services, groups and facilities, opposing the increasing sexualisation and objectification of women and girls, exposing the harms of the global sex trade and surrogacy as violations of women's human rights and ending male violence against girls and women.

Vee Malnar Committee Member (21/6/19 -)

Accomplished songwriter, playwright, musician and painter. In 2006 Vee established the Sydney Mamapalooza Arts Festival which celebrates, promotes and inspires mothers' contributions to the performing and visual arts. Vee is the 2014 recipient of the Edna Ryan Arts Award for her efforts to make a feminist difference.





In July 2018 I represented Feminist Legal Clinic Inc. as an NGO delegate at the United Nations in Geneva for Australia's report to the 70th session of the Convention on the Elimination of all Forms of Discrimination against Women (CEDAW). Our written communication to the committee, drafted with assistance from Darelle Duncan, focused on the need for greater recognition of maternal rights with reference to the harm caused by adoption and surrogacy, the need for family law reform and

the restoration and expansion of women's support services. Some of the specific concerns raised in our report and at meetings with CEDAW members in respect to family law and women's services were referenced in the committee's Concluding Observations, although the Committee was less responsive on some of the more divisive issues such as surrogacy.

With funding from a matching grant from the City of Sydney Council, FLC finally held its formal launch on 20 February at Benledi House. Councillor Jess Miller represented the Council at the event and a speech was also made by founding committee member Professor Rita Shackel from the University of Sydney Law School. The event was chaired by then current convenor Associate Professor Bronwyn Winter and Charmaigne Weldon delivered the welcome to country. Catering was by refugee kitchen "Four Brave Women". Thanks to the hard work of a team of committee members and volunteers the event was a success with over 60 people in attendance.

With leftover money from the launch a second event was held in June with a panel discussion "How must the law change to stop male violence? which attracted a vocal crowd and robust audience participation. There were calls for further activism on this issue. I would like to thank the attendees from both launch events who provided overwhelmingly positive feedback to our survey which was then submitted to Council as part of the acquittals process.

Having last year negotiated a 12 month reprieve for the Women's Family Law Court Support Service, Feminist Legal Clinic Inc. continued to campaign with the coordinator Sruti Sinha for secure ongoing funding for this service. We would like to acknowledge the support to save the service from the then NSW Shadow Minister for the Prevention of Violence, Jenny Aitchison and NSW Greens MPs David Shoebridge and Jamie Parker. We are also grateful to the thousands who signed the Change.org petition and for the support of the Family Court and the coverage provided by ABC News. Unfortunately, despite our efforts the government was not forthcoming and after being re-elected they proceeded to cut funding to this essential domestic violence support service.



Sydney Family Court

Rather than lose a service that had been operating over 10 years and is one of the few remnants of the NSW Women's Refuge Movement, we decided to step in and take over operation of the service from July 2019. At short notice we organised a roster of volunteer women to take over the job of providing non-legal support to women caught up in toxic family law proceedings. I would like to thank the many women who put their hand up to make this possible while we continue to campaign for reinstatement of funding.

Aside from the many traumatic experiences recounted to us by women caught up in toxic family law proceedings, we have also been disturbed to hear that male perpetrators are increasingly naming women as defendants in domestic violence proceedings in the Local Courts. To investigate this further we have collaborated with the University of Sydney Law School on research looking at women defendants in domestic violence proceedings and are grateful to Professor Rita Shackel and her team for leading this project.





Declaration on Women's Sex-Based Rights



On a somewhat lighter note, our grant application to the NSW Government for a community project involving the erection of a "Memorial Statue for Mothers" based on a drawing by Mary Leunig was ultimately unsuccessful. However, with Mary Leunig's support we intend to continue negotiations with the City of Sydney Council in the hope of furthering this project sometime in the future.

During the 2018/2019 year Feminist Legal Clinic Inc was also appointed as the country contact for the international Declaration for Women's Sex-Based Rights established by the international Women's Human Rights Campaign led by Sheila Jeffreys and others. The Declaration was launched in March 2019 and re-affirms women's sex-based rights, including women's rights to physical and reproductive integrity, and the elimination of all forms of discrimination against women and girls that result from the replacement of the category of sex with that of 'gender identity', and from 'surrogate' motherhood and related practices. It has thousands of signatories already from all around the globe and we urge you to consider signing it if you have not already.

These are just a few of the projects we have worked on in the 2018/2019 year. Aside from our law reform and community education work we have also juggled our advice service and casework and have posted over 640 entries on our blog, which provides abridged news reports and articles on feminist issues, attracting over 1,000 visitors per month. With assistance from Spider Redgold from Feminine Byte we have upgraded our website and have added payment facilities for membership and donations. So if you support what we are doing and have not already joined as a member, we would ask that you please join up as soon as possible and help us continue our work.



Project Reports

Financial Abuse Legal Clinic

The Financial Abuse Legal Clinic was set up as a project of the Feminist Legal Clinic. The aim was to provide legal advice and representation for women experiencing financial abuse. Financial abuse is a type of domestic violence which can include controlling and harmful behaviour that relates to money. An example of financial abuse is controlling or limiting access to money.

In 2019, the Financial Abuse Legal Clinic provided assistance to a small number of clients. Advice was provided on dealing with the financial consequences of domestic violence. It was apparent from running the service for even a few months that women experiencing or escaping family violence do need support and legal advice on financial issues.

Women Write Wiki

The Women Write Wiki group continues to meet fortnightly at The Women's Library. In 2018-19 we have created more than 50 articles, many being biographies of women, plus years in Australian literature, Australian publishers and Australian honours lists. Existing articles, such as on the Edna Ryan awards, have also been updated and more than 15,000 individual edits made.

Pru Mitchell, the President of Wikimedia Australia visited and praised our efforts as a long-standing active group. Two members attended the Worlds of Wikimedia 2019 conference (https://www.wow2019.net/), followed by the Wikimedia Australia Community Conference in June. It was a welcome opportunity to meet and learn from other Wikimedians face to face. Following this, our group was pleased to be joined by an experienced editor who specialises in writing about flora, as well as women.





Membership Report

In December 2018 our website was set up to accept membership applications and payments through PayPal. Since first tested by Spider Redgold, 39 more people have joined, including eight as client members, in the 2018-19 financial year. Two women made a second membership payment and these amounts will be credited towards their 2020-21 fees. Most women joined around the date of FLC's Launch in February and just after our first Newsletter was sent out in late March. One organisation took out membership in the 2018-19 financial year.



Treasurer's Report

Annual General Meeting of Feminist Legal Clinic Inc. for the Year ending 30 June 2019

For the financial year ending 30 June 2019 Feminist Legal Clinic Incorporated received \$12,232 in income. This comprised a combination of grant funding, interest, donations and membership payments. Expenses came to \$6,690.

We began charging membership and accepting donations from December 2018 after the website was upgraded with the PayPal facility. We have raised \$470 in membership fees and \$770 in donations by this means. In addition, we received a matching grant from the City of Sydney Council for \$5,250, enabling us to launch and promote our service. This money has been successfully expended and an acquittals report submitted to and approved by the City of Sydney Council. In May we received a \$5,000 grant from the Department Social Services towards the cost of equipment and training for our volunteers in the coming year.

We continue to be grateful recipients of an accommodation grant from the City of Sydney Council, providing a 100% rental subsidy on the office space we share with Pride History Group at Benledi House in Glebe.

A number of operating expenses were again personally covered by the Principal Solicitor, with support from Bok Consulting Pty Ltd. These expenses have included the insurance premium, the Principal Solicitor's practising certificate and mandatory legal training, telephone and internet costs, office equipment, stationery, printing and some incidental expenses.

One significant expense funded by the Principal Solicitor was the cost of flights to Geneva to attend Australia's report to the 70th session of CEDAW at the United Nations, while her accommodation, meal expenses and training during this trip were funded by IWRAW Asia Pacific. The Principal Solicitor also covered other travel and accommodation expenses within Australia, including an airfare to attend and present at the International Domestic Violence & Health Conference in Melbourne, while the conference fee was generously covered by Professor Rita Shackel.

At 30 June 2019 our account with Bendigo Bank had a balance of \$8,150 and the PayPal account balance was \$41. There are no mortgages, charges or securities of any description affecting any part of the property of the Association as at 30 June 2019.
