Global coverage of case of Jay Langadinos

In August there was extensive media coverage of the case of Jay Langadinos who is suing the psychiatrist who fast-tracked her onto hormones and into having a mastectomy and hysterectomy. We have been supporting Jay for several years and referred her to medical negligence lawyer Anne Shortall at Slater & Gordon who has previously run cases of this type. Proceedings were filed earlier this year and a timetable has been set for the proceedings. Following the original exclusive media coverage by Julia Szego at The Age/SMH, the story was picked up by many other outlets in Australia and internationally and a selection of links follows. We have since heard from more young people who have been similarly harmed.

Two hands-on learning opportunities for Sydney-siders are coming up. On 22 October there's an Introduction to Wikidata: [How worlds of Wikimedia link](#). Wikidata is a structured database that underpins English Wikipedia, the other language Wikis and Wikimedia Commons, where all the images are kept. Data visualisations can be produced to show query results, including gender bias in academia compared with the movies.

Then, on 12 November there will be an Introduction to Wikipedia, including signing up for an account and making your first edits.
