## Our vision

Our vision is a world where women and their children are liberated from discrimination, exploitation, abuse and violence and the empowerment of women and girls is prioritised and achieved in every sphere of their lives. Core to this vision is ensuring that all women and girls are free to enjoy the status, independence and power necessary to participate equally in private and public decision-making, and control and share equitably in all economic, social, cultural and political resources and capital.

## Our objectives

Our work is directed toward recognising women’s agency and giving voice to the lived experiences of all women and girls in order to drive systemic and cultural change that promotes and improves women’s individual and collective access to quality legal support and services, and the universal fulfilment of women’s human rights, their legal entitlements and delivery to women of just outcomes. We seek to progress feminist projects and activities on behalf of clients and our partners, and to pro-actively campaign and drive a feminist agenda for connecting policy and practice and educating the community and profession. We are committed to developing and building strong collaborative networks and partnerships, including with universities and students, practitioners, the legal profession and other community justice services, to pursue our mission and vision in advancing the feminist cause. We intend to work towards this through undertaking a mix of targeted casework, law and policy reform, strategic research and advocacy projects, and promoting community and professional engagement, training and education.

## Convenor's Report

Our committee meets throughout the financial year to discuss ongoing legal work, fundraising and our struggle to obtain Deductible Gift Recipient (DGR) status. We continue to see women experiencing stressful and difficult legal actions particularly those dealing with domestic and family violence, including women for whom this is further complicated by Culturally and Linguistically Diverse (CALD) or refugee status. We are also meeting with increasing numbers of women who are detransitioning from previously held gender identities. This is complex, and the bravery of women in this area is profound. We are fortunate to have such devoted committee members with an incredible breadth of knowledge and experience.



We continue to increase our membership base, and gratefully acknowledge the work of our Treasurer, Marianne Bryant, in managing membership applications and payments and negotiating various software challenges. Members who would like to volunteer as researchers are always welcome to join our various projects, and we encourage them to do so.

## Principal Solicitor's Report

Feminist Legal Clinic Inc. has continued to operate, although at reduced capacity following the loss of our premises and competing demands on my time. Caring for my mother in Port Stephens has meant that I have had to temporarily give away my domestic violence advocacy work in the local courts in Sydney. I also apologise to members that I have not managed to continue to produce our quarterly newsletters during the year.

### Casework

Our database records that during 2022-2023 we had over 122 contacts with clients by email or telephone where we have provided basic advice/information/referral, plus an additional 64 contacts through the Women's Court Support Service. In addition, we opened 18 new files for clients needing ongoing assistance, as well continuing our existing casework for groups and individuals.

For reasons of legal confidentiality, we cannot share many details of the cases we work on, but below is one photo from satisfied customer Pearl Moon, who was eventually able to exhibit her work as a finalist at the Australian Wearable Art Festival (AWAF) following intervention by Feminist Legal Clinic. You can read about Pearl's story on Glinner's Substack and Unherd. This photo shows Pearl with her entry at AWAF titled Wedding Dress for a Woman to Marry Her Garden.

The publicity surrounding the case resulted in an American art collector contacting her and purchasing Pearl's garment to include in a show along with the work of 14 other artists from around the world. The exhibition, titled A Nasty Piece of Work: Art of Dissident Feminists, was launched in San Francisco to coincide with the opening of the second International Women's Declaration conference in September 2023. Aside from our casework, FLC also engages in community legal education work, including giving presentations and maintaining a news digest blog about matters significant to women's human rights. We have published over 700 posts on our news digest and according to our website statistics, our service has had over 30,000 visitors in the past year, which is approximately 10,000 more than the previous year. We had over 5,000 visitors in the month of June 2023 alone.

We also undertake law reform work to address the systemic causes of women's disadvantage and distress. Details of this work can be found in the following list of our submissions, presentations and media coverage. Links to this material can also be accessed through our website.

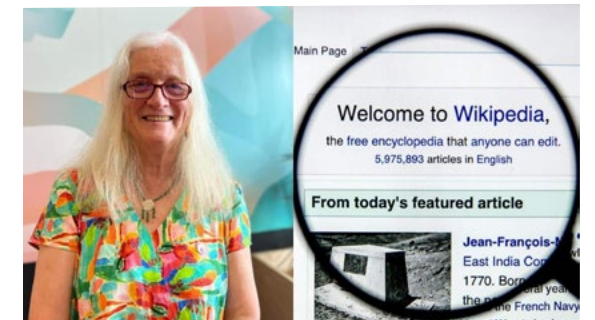

## Project Reports

### Women’s Court Support Service

COVID19 restrictions have really changed the face of court rooms. Most hearings are now held online with trials face-to-face. Our service made it through this time, however, and took on new volunteers, including the indefatigable Fiona to whom we are very grateful. We have been reworking our manual for volunteers as well as liaising with the various other groups that also work in the court building such as Relationships Australia and Legal Aid. Our volunteers bring a broad range of skills, experience and diversity to the service and it’s been wonderful getting to know new women who are also committed to women’s wellbeing in the courts.

We have continued to work on the Hague Mother’s project with FiLiA and recently women in the European group presented the work of many volunteers, including us, to the UN. It seems Australian politicians are receptive to changing how these laws impact mothers and we are thrilled to see this.



Sadly, for the Women’s Court Support Service, and despite the years of commitment from so many women, it appears we are set to lose our office space. I would like to thank all the volunteers, over the years, and all the women who trusted us with their stories. We have all been enriched by our work and it is very sad that we will no longer be able to provide this space for women. Family law is one of the most stressful, and dangerous times, of many women’s lives. The little we have been able to do to ameliorate some of that stress has been an honour.

We acknowledge the support of Sydney Family Court for continuing to provide the office space for the Women’s Court Support Service.



While we welcome moves to criminalise coercive control in theory, our main concern is the potential misuse of these provisions against women by male perpetrators of abuse.

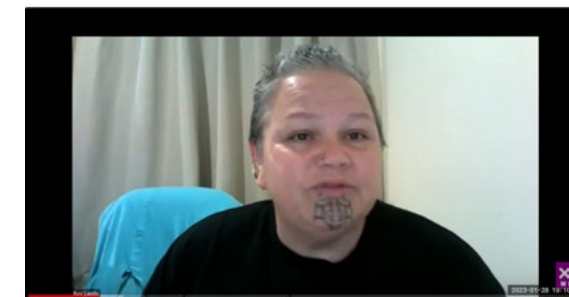
