## Our vision

Core to this vision is ensuring that all women and girls are free to enjoy the status, independence and power necessary to participate equally in private and public decision-making, and control and share equitably in all economic, social, cultural and political resources and capital.

## Our objectives

Our work is directed toward recognising women's agency and giving voice to the lived experiences of all women and girls. We aim to secure robust social and cultural systems and environments that promote and improve women's individual and collective access to quality legal support and services. We believe women are entitled to equitable treatment at law, just outcomes, and the universal fulfilment of their human rights. We seek to progress feminist projects and activities on behalf of clients and our partners, and to pro-actively campaign and drive a feminist agenda for connecting policy and practice, as well as educating the community and the legal profession. We are committed to developing and building strong, collaborative networks and partnerships, including with universities and students, practitioners, the legal profession and other community justice services, to pursue our mission and vision in advancing the feminist cause. We intend to work towards this through undertaking a mix of targeted casework, law and policy reform, strategic research and advocacy projects, and promoting community and professional engagement, training and education.

We continue to provide submissions and advice to state and federal governments and the UN on related issues.

## Principal Solicitor's Report



### Casework Report

In 2024-2025 we saw extremely disappointing decisions handed down in two high profile cases in which we provided the initial legal representation and briefed barristers who subsequently advanced the matters through the court system.

On 23 August 2024, Justice Bromwich of the Federal Court determined that Roxanne Tickle, a man identifying as a transwoman and legally recognised under Queensland law as female, had been indirectly discriminated against under the Commonwealth Sex Discrimination Act 1984 (SDA) by Sall Grover, both as an individual and as CEO of Giggle for Girls Pty Ltd, when she excluded him from their online networking app for women. Bromwich J uncritically accepted submissions on behalf of the Sex Discrimination Commissioner that sex is not binary, not based in biology and can be changed. Bromwich J ordered Giggle to pay damages of \$10,000 to Tickle as well as the substantial costs of the case.



My case note summary of 'Tickle v Giggle - No Laughing Matter' has been published in the Denning Law Journal and can be accessed [here](#). This decision was subsequently taken on appeal by the Giggle legal team to the Full Court of the Federal Court and we are currently awaiting the court's decision.

Shortly after the Tickle v Giggle decision, on 2-3 September 2024, we provided legal representation and instructed barrister, Leigh Howard, in the matter of Lesbian Action Group v Australian Human Rights Commission. This case involved a review by the Administrative Review Tribunal of the decision by the Australian Human Rights Commission (AHRC) to refuse Lesbian Action Group (LAG) an exemption to hold lesbian events that excluded all males, including those who identify as transwomen. Unfortunately, Tribunal member Fenwick was heavily influenced by the Federal Court reasoning in Tickle v Giggle and on 20 January 2025 handed down a decision upholding the AHRC's refusal to grant LAG the exemption sought.



An appeal in the LAG v AHRC matter has been filed with the Federal Court and in view of the clear nexus between the issues in that matter and those to be considered in the Giggle v Tickle appeal, LAG lodged a successful application to intervene in the latter proceedings in the Full Court of the Federal Court. The Giggle v Tickle appeal, including the LAG submissions presented by barrister Leigh Howard, was heard on 4-7 August 2025 and we are currently awaiting the court's decision.

In both these cases we have chosen to conserve our resources by stepping aside at a point when it was clear that these clients could be adequately supported by alternative legal teams, including past volunteers of Feminist Legal Clinic who have subsequently entered independent legal practice.

As our legally qualified volunteers inevitably move on to paid positions, we continue to struggle with capacity to take on substantive casework. Our database records that during 2024-2025 we have provided preliminary advice, information and referral by email and/or telephone on 82 occasions, in addition to having, at any one time, approximately 20 open files.

There is considerable demand for assistance, which we cannot come close to meeting, from the many Australian women who are defending attacks upon their sex-based rights, whether in the workforce, in female facilities or in sport. Without support many of these women will struggle to defend themselves. Unfortunately, Legal Aid and the community legal sector are entirely beholden to trans ideology and provide no recourse for these women.

Our clients also include those recovering from the trauma of misguided 'gender affirming' medical interventions that have left them both psychologically and physically harmed. We do not have the resources to take carriage of these substantial personal injury claims but support these women to find appropriate plaintiff law firms resourced to take on these proceedings. This includes women like Mel Jeffries who, with representation by Anne Shortall of Slater and Gordon, commenced medical negligence proceedings in May 2025 against the doctors responsible for her injuries.



Unfortunately, we continue to struggle to find appropriate referrals for other detransitioners. Most law firms are reluctant to take on these important cases, which come with multiple challenges including difficulty finding appropriate and willing medical experts, time limitation issues, and highly traumatised clients. There is also a pervasive fear of possible reputational damage if firms are involved in these highly controversial matters.

I continue to post on our news digest blog, having made 6,381 posts to date, including 694 in the last financial year. We have 294 subscribers plus over 1.6k followers on Facebook. In the 2024-2025 financial year we had 41.4k views and 25.8k visitors.

These statistics are a reduction on previous years, and no doubt reflect the fact that my attention was increasingly divided as I was also involved privately in bringing litigation in the Land and Environment Court in an effort to save the forests, wildlife and regional community where I was raised from massive and inappropriate quarry developments. Unfortunately, this is an equally frustrating and inequitable jurisdiction where the environment, like women's human rights, is being sacrificed on the altar of profit for big business.

## Thanks to Volunteers, Members and Management Committee

It is an important role of Feminist Legal Clinic to provide female law students with the opportunity to complete their qualifications and obtain the needed experience to enter legal practice. I was pleased to be able to supervise Dr Megan Blake complete her Practical Legal Training before she was admitted to the bar. She has since been in a position to continue her work as a member of the legal team for the Lesbian Action Group, independent of FLC. We also welcomed Dr Megan Blake to our management committee in 2024-2025.



Before being admitted as a barrister, Megan also did a stellar job attending the early morning WDI country contact meetings and providing a weekly report from Australia. However, now that Megan is working as a barrister this position is again vacant, so please get in touch if you are interested.

Currently I am also supervising the Practical Legal Training of our convenor, Janet Fraser, who recently completed her law degree and will shortly be looking for a position in paid legal practice. Thanks go to Janet for convening our management committee meetings as well as organising speakers and hosting the monthly WDI Aus/NZ webinars, which are then conscientiously edited by the wonderful Marietta. Marietta has recently chosen to step down from our management committee under the weight of other responsibilities but her ongoing help with editing these videos continues to be indispensable.



Other members of the management committee, including Professor Helen Pringle, barrister Elizabeth Johnson and solicitor Dr Catherine Lynch, have long been generous with advice and assistance in their respective areas of expertise, while Bronwyn Williams has filled an invaluable role as my constant proof reader and sounding board.

I would like to thank those who have donated to Feminist Legal Clinic, including those who generously make regular payments, and all our members for their ongoing support and encouragement for our work. I do not find time to engage personally with each of you, but please be assured I am aware of and appreciate your payments and comments.

Finally, I thank Marianne for her continuing administrative support in the role of membership officer and completing the necessary bookkeeping that goes with that role. Marianne has again kindly prepared the financial statements for the year but remains keen to relinquish this responsibility. Please contact me if you are interested and have the capacity to take this on.
